

2018 was a year of celebration, prospection, and growth. We honored our 50th year in Hawai'i and made big changes to better our future together in the islands. Our statewide supporter base **increased by 6%** and our membership **increased by 3%**.

In and outside of the capitol, our grassroots advocacy remains as effective as ever. In 2018, our lobbying helped a handful of strong, leading-edge environmental laws get adopted, including Hawai'i's commitment to be carbon neutral by 2045, banning toxic reef-killing sunscreens, and—after years of advocacy—establishing performance based rates for our electric utilities.

We also engaged with agencies to ensure established laws are followed. Volunteers at the Chapter and Group levels submitted comments on a dozen development projects that jeopardize our environment, including Mauna Kea, Hū Honua, and AES.

In 2018, our volunteers hosted over 200 outings—177 hikes and 54 service projects throughout the islands. We marked our half century by sharing our most treasured places on 19 "Victory Hikes". The O'ahu Group also coordinated 6 trail clearing days and organized 20 Sierra Club volunteers to lead hikes for over 200 community participants during the first annual Ka Iwi Explorations.

This is the most effective way to make our advocacy victories a reality. But it is also a slow and sometimes expensive undertaking. In 2018, the Sierra Club of Hawai'i was actively pursuing 9 cases.





The climate is changing faster than ever, and in 2019, the Sierra Club of Hawai'i is laser-focused on adapting to the impacts we are already seeing and mitigating what future impacts we can. This means

looking holistically at local climate change issues and implementing innovative ideas to protect our islands and people from the worst effects of climate change.

WATER SECURITY

Climate change brings with it threats to freshwater availability increased droughts, storm activity, and rising seas. The Sierra Club of Hawai'i is advocating for the return of waters to public streams previously monopolized by sugar barons and corporations, better management of watersheds, and the protection of our aquifers from pollution.

CARBON FREE HAWAI'I

Hawai'i has committed to being carbon neutral by 2045 and the Sierra Club of Hawai'i is dedicated to making sure that happens. We are working to ramp down our islands' reliance on dirty fossil fuels and completely cut our coal dependence, increase our clean energy production, all the while planting more trees to sequester the carbon already in the atmosphere.

LAND STEWARDSHIP

Nature-based solutions provide effective and less intrusive mitigation and adaptation to climate change. The Sierra Club of Hawai'i supports projects that return nature to nature and benefit society. This means pushing for local sustainable agriculture, like permaculture and native food systems, reforestation projects that improve soil health, and preserving open spaces and nearshore waters.
